SUFFOC Hundred Acre Walk Event

1. **Executive Summary**

This report relates to the SUFFOC orienteering Level C event held on Sunday 2nd Oct 2011 at Hundred Acre Walks (Daisy Wood). Two of the controls; number 3 and 7 on the Green course, were positioned approximately 50m apart. The overprinting of the course on the map (which included the control circle and its associated sequence number) was such that the numbers of the controls ended up adjacent to the wrong circle which caused varying degrees of confusion to the competitors on the course.

A complaint was raised by one of the competitors, Peter Waldron, who was disqualified as he had punched out of sequence. He thought that the results of other competitors had been changed whereas his had not the implication being that he and two other named competitors should be reinstated. The complaint has been investigated by the Organiser for the event (Louise Walker SUFFOC) in accordance with the BOF Rules of Orienteering. [Rule 9 and Appendix G refer].

During the course of the investigation it became apparent that competitors starting after 11:20 were informed of the 'problem' with controls 3 and 7 and it has been suggested that this gave these competitors an advantage over the other earlier starters. Members of the EAOA on-line discussion group (John Ward, Barbara Fothergill, Richard Barker) have suggested that the results should not be used for the East Anglian League. Although no formal complaint was raised in accordance with the BOF rules, the Organiser has extended this investigation to review the results and to determine whether the problem has adversely affected the results to the extent that either

- the affected leg should be voided to put all the competitors on a level playing field or
- the entire race results voided for the purposes of the EA League.

The investigation has found that the problem with the overprinting caused a varying degree of confusion to the competitors ranging from apparently no effect at all with competitors finishing in the top 5 who were not aware of the problem to competitors punching out of sequence even when they were forewarned.

No changes had been made to the other competitor's results with respect to mis-punching

It is a requirement for competitors to punch in sequence therefore the complaint has not been upheld. The competitors shall not be reinstated.

Voiding the affected leg 2 to 3 would have no effect on the relative positions of the top 5 finishers of the overall competition nor would it affect the relative positions of the finishers by age group. The published final results (with all legs included) stand and they shall be used for the EAL.

2.4. Objectives

This investigation is not to allocate blame but for lessons to be learnt by the event officials and the competitors to avoid a similar situation to occur to ensure that future SUFFOC orienteering events are provide which remain challenging but enjoyable.

- 2.4.2. To determine the immediate and root causes
- 2.4.3. To determine any failures of the organisation, planning or controlling of the event in accordance with the BOF Rules
- 2.4.4. Whether the complaint should be upheld
- 2.4.5. To ensure that the final results reflect the correct relative ability of those who competed on the day

3. Event Summary

3.1. Description of the event

During the planning of the courses leading up to the event, 'Travellers' illegally occupied an area in Hundred Acre Walks which required a complete re-plan of all of the courses including the relocation of the start to avoid the area which had been occupied by the travellers. The original Green course controls 3 and 7 were separated by a conventional distance, and the OCAD automatic numbering was clear, with the figure 7 due north of the control circle and the 3 due south of its control circle - but this was approx 2.5cm from control 7. In the last week, the Planner moved control 3, after consultation with the Controller, to take it away from woodland that was adversely affected by traveller activity. OCAD automatically moved the control number with the control circle, such that the figure '3' ended touching the control circle for 7 and the figure '7' next to the control circle for 3. The over printing was not checked as the maps were only printed hours prior to the competition. Therefore this 'error' was not picked up prior to the start of the competition by either the Planner or the Controller. The error caused some competitors to think that the circle for control number 7 was number 3. One of the competitors, Simon Peck, reported the problem to the Controller after he had downloaded at 11:12. After due consideration the Controller then asked the Start officials to warn runners on the Green course that numbers 3 and 7 were effectively transposed, but that the lines and circles were correct. This warning was given to all competitors starting after approx 11:20.

3.2. Complaint

Peter Waldron sent the following e-mail on Monday 3rd Oct after the final results were published to SUFFOC club secretary, Clive Wilkinson, requesting that it should be forwarded to the event organiser.

'I see that I was recorded as mis-punching at the event on Sunday, but if you look at the splits you'll see that all the controls are there. The misprinting of controls 3 & 7 on Green meant that I punched 120 as if it were no 3, and 166 as 7. It looks as if this has been corrected in most cases, but there are three people (myself, Jeremy Gray & Simon Clamp) where the correction hasn't worked.' (The implication being that the three competitors should be reinstated)

3.3. Summary of evidence

3.3.1. Paul Lowe did not change anything to do with the order that anyone punched the controls. Peter Waldron, Jeremy Grey and Simon Clamp were the only 3 that did not punch the affected controls (3 and 7) in the correct order. Nine other competitors had wrongly punched 120 as control 3 but then punched 166 straight afterwards. This can be seen in the splits and is recorded as times above the asterisked control number.

- 3.3.2. The physical position of the controls on the ground where correct to the position of the control circles on the map
- 3.3.3. The control descriptions were correct on the control description sheet
- 3.3.4. Control #3 and #7 were correctly numbered 166 and 120
- 3.3.5. The lines on the map joined the circles in the correct sequence.
- 3.3.6. Controls #3 and #7 were located close to one another and they were approximately 50m apart. This is permitted under BOF rule 6.2.4 as they were on differently described features and in different areas of forest;
 - control #3; Control number 166, north side of earth wall, 'dark green' forest and
 - control #7; Control number 120; small depression, 'white' forest
- 3.3.7. The control sequence number '3' on the map was next to the control circle for number 7. This was the only misleading factor.



3.3.8. Correcting 'problems' during a race is permitted. [BOF Rule 3.3.1/ Para 1) refers]. Therefore the decision by the Controller to inform late starters of the problem was correct. However the remaining maps should have been overwritten with a red pen to correct the error.

3.4. Factors considered

3.4.1. Summary of the results

Of the 32 competitors on the green course, 25 completed the course, 4 mis-punched and 3 retired (one due to injury)

Of the 25 who successfully competed the course;

3.4.2. The results were re run with the leg between controls 2 and 3 voided and analysed with respect to the relative finishing positions of the competitors.

4. Conclusions

- 4.1. Reinstatement of the three competitors who transposed control #3 and 7
 - The control description sheets and the lines linking the controls were in the correct sequence. The site equipment was correctly marked. The control sites were on differently described features. It is the requirement of the competitors to follow the marked course in the correct sequence and therefore the three competitors (and Alexander Ware who punched 1, 2, 3, 6, 5, 4, 8....) shall not be reinstated. [BOF rule 6.5.6 refers.]
- 4.2. There was a mixed reaction by competitors to the problem as some of the competitors who were advised of the problem still failed to have a 'clean' run. Therefore it cannot be proved that those who started after 11:20 had an advantage over those who were unaware of the problem.
- 4.3. The purpose of an orienteering event is to determine the best Orienteerer on the day. As it can be shown that the relative positions of the top 5 finishers does not change when the affected leg is voided then the results as published stand. [BOF Rules/ Appendix I/ 3.1.2 and 3.2.3 refers].
- 4.4. There are no Guidelines for the East Anglian League other than the document on the web site 'How the EAL Works'. http://www.eaoa.org.uk/league2010/EALrules.htm. Therefore the BOF Rules apply.
- 4.5. The relative positions of the finishers for each age group for the purposes of calculating the scores for the East Anglian League did not change. The final results as published shall be used to calculate the scores for the EAL. [BOF Rule Appendix G/ 3.4.2 refers]
- 4.6. Immediate causes
 - 4.6.1. Travellers occupying an element of the competition area
 - 4.6.2. Last minute adjustment of the courses by the Planner to avoid the travellers resulting in the control sequence numbers touching or being close to other control circles on the map

4.7. Root Causes

- 4.7.1. Lack of 'quality' check by the Planner and /or the Controller meant that the error was not identified before the start of the competition
- 4.7.2. Competitors not following the controls in the correct sequence by following the joining lines
- 4.7.3. Competitors not following the correct sequence as per the control description sheet

5. Recommendations

- 5.1. All Competitors affected on the Green Course at the SUFFOC event at Hurdred Acre Walks on 2nd Oct shall be entitled to free entry to the next SUFFOC event.
- 5.2. Sufficient time to be factored into the planning of courses to allowed the Planner and the Controller to quality check the overprinting of each course.
- 5.3. Hard copies of the BOF Rules and Appendices to be available at all future SUFFOC events
- 5.4. Hard copy of the EAL Rules to be available at all future SUFFOC events
- 5.5. All competitors familiarise themselves with the BOF rules and relevant Event Guidelines and in particular.; Rule 9 'Complaint, Protests and Appeals'
- 5.6. All competitors should follow the 'Golden rule of orienteering'....ONLY GO AS FAST AS YOU CAN READ THE MAP [see http://myweb.tiscali.co.uk/magnus/orientgoldenrule.html]
